Steps for Online Registration:

1. For those of you who are computer friendly simply go to www.azvi.org then hit the Summer Camp link
2. This link will bring you directly to the online registration page. 2014 Camp families will simply need to update any information on your account then register for the weeks of camp, field trips, lunches etc. New camp families will need to set up **YOUR own private account** with a user name & password! Once your account has been set up, **one time only** you will have to enter all of your personal family & camper information. Once your account is set up, you will only need to update it as needed.
3. For those of you who may need help with the online procedures we will have computers set up in our camp office & personnel there to assist you with setting up your account & registering your camper.

Beginning Tues May 5th, 4:00pm to 6:00pm the camp office will be open every Tues & Thursday to assist you with online registration and any & all camp business.

- **May 4th until May 17th** - Open to the Public with a registration discount = **\$35.00**
- **Register On or After May 18th** — ongoing throughout camp - No Discount on registration = **\$45.00**
- **One check:** for all campers per family, **Payable to:** Camp @ AZ Academy or Visa or Master Card
- **An informational newsletter** will be posted online for all by late May. This newsletter will explain lots of information concerning camp such as daily car rider drop off/pick up, field trip sign-up, supplies needed, an updated calendar, camper behavior expectations and staff bios.
